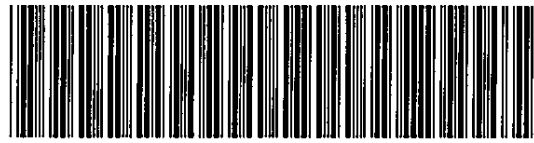

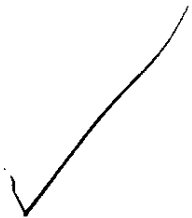

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The purpose of Unity Community of Joy, Inc. is to teach the universal principles of Truth, as taught and demonstrated by Jesus Christ and interpreted by Unity and the Association of Unity Churches, a nonprofit corporation organized and existing under the laws of the state of Georgia with headquarters at Lee's Summit, Missouri.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Initial officers will be volunteers appointed by the Spiritual Leader. Upon induction of the first membership class, the Board of Trustees will be elected by the membership in the following manner

Any person elected to the Board of Trustees must be an active member of Unity Community of Joy, Inc. A Nominating Team will be formed at least three months prior to the annual membership meeting, and will initiate a search for at least two qualified candidates for the Board of Trustees. The Nominating Team will consist of the spiritual leader/minister and three active members. The Nominating Team will present the nominations at the annual membership meeting and call for additional nominations from the floor. The two nominees receiving the largest number of votes will be elected to full 3-year terms. The candidate receiving the next highest number of votes will be elected to the longest unexpired term that is vacant, etc.

Officers of the Board of Trustees will be selected in a manner decided by the Board at the first Board meeting following the annual meeting, or at a special meeting called for the purpose of selecting officers. Officers will hold their respective offices for one year or until their successors are duly elected.
