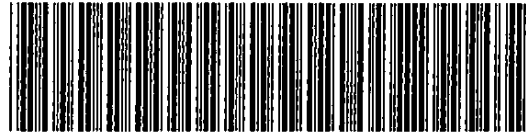

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLES I: NAME

The name of the corporation shall be: ACCESS MINISTRIES INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
3758 ROLLINGSFORD CIRCLE, LAKE LAND, FL 33810

ARTICLE III: PURPOSE

The purposes for which this corporation is formed are exclusively religious, charitable, literary and educational and consist of the following:

1. To establish and maintain a place for the worship of God; to provide for Christian fellowship for those of like faith; to assume our share of the responsibility and the privilege of sharing the gospel of Jesus Christ by all available means, both at home and abroad.
2. To provide an environment where any and all can be accepted and have their needs met through spiritual worship, guidance, support for one another. And, further, to provide relief to the poor, the distressed and the underprivileged by engaging in or supporting activities to create jobs, provide affordable housing, and provide needed services.
3. To aid, support, and assist by gifts, contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for religious, charitable, literary and educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
4. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
5. All of the foregoing purposes shall be exercised exclusively religious, charitable, literary and educational purposes in such a manner that the Corporation will qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV: MANNER OF ELECTION
