## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PIER RESORT CONDOMINIUM ASSOCIATION, INC.

Pursuant to the provisions of §617.1006, *Fla. Stat.*, PIER RESORT CONDOMINIUM ASSOCIATION, INC. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

## FIRST: Amendment adopted:

Article 10. Section 10.1 of the Articles of Incorporation of Pier Resort Condominium Association, Inc. ("Articles of Incorporation") is hereby amended as follows (additions are indicated by <u>underlining</u>: deletions are indicated by <u>strike outs</u>, omitted and unaltered provisions are indicated by ellipses):

ARTICLE 10 DIRECTORS

Number and Qualification. The property, business and affairs of the Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-Laws, but shall consist of not less than three (3) directors. Directors not appointed by the Developer must be members of the Association or residents of units in the Condominium Unit Owners, as that term is defined in the Association's Declaration.
