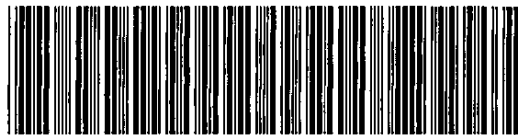

## ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

### ARTICLE I

#### NAME OF THE CORPORATION

The name of this corporation shall be Spiritfilled Life Multifunctional Service Center, Inc.

### ARTICLE II

#### PRINCIPAL OFFICE

The address of this corporation is 5804 Wintergarden Parkway, Fort Pierce, Florida 34951.

### ARTICLE III

#### EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

### ARTICLE IV

#### PURPOSE

The purpose of the center is to provide needed support services to the Fort Pierce area communities. Services are to include charitable, literary, and educational programs such as adult literacy programs, GED education classes, mentoring programs, and other programs to help reduce the social burdens to the local governments.

The purposes for which Spiritfilled Life Multifunctional Service Center, Inc. is organized are exclusively charitable, literary and educational within the meaning of section 501(c)(3) of the Internal revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The powers of Spiritfilled Life Multifunctional Service Center, Inc. are limited to those within the scope of section 501(c)(3) of the internal revenue code of 1986 of the corresponding provision of any future United States Internal Revenue law.

Articles of Incorporation

Notwithstanding any other provision of these articles, Spiritfilled Life Multifunctional Service Center, Inc.. shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE V  
DIRECTORS

The business of the corporation shall be conducted by a Board of Directors which shall consist of not less than three (3) unrelated persons as shall be designated by the by-laws, and elected at the annual meeting, or at a specially-called meeting for the purpose of electing a director of this corporation. The initial board of directors, all of whom shall hold office until their successors are duly elected and qualified, and their addresses are as follows:

ARTICLE VIII  
FUTURE DISTRIBUTION OF THE ASSETS

Upon dissolution of the organization all assets shall be transferred to a 501(c)(3) or its (501(c)(3)) assigns. Should this not be possible then all assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 , or corresponding section of any future Federal tax code, or shall be distributed to the Federal, State or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.


