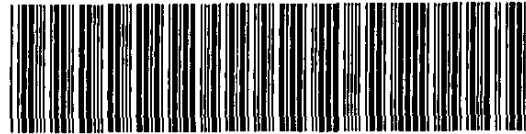


ARTICLE X- POLITICAL ACTIVITY


