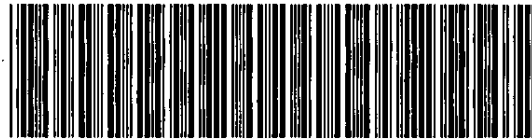


Dear Becky,

ARTICLE I.

CORPORATE NAME

The name of this corporation is Patrick's Place, Inc.




