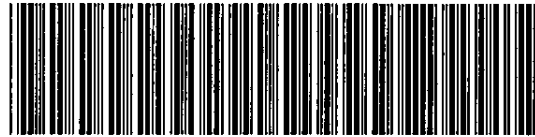

**ARTICLE I - NAME** -- The name of the corporation shall be FRIENDS OF SANTA ROSA COUNTY, INC.

**ARTICLE II - PRINCIPAL OFFICE** -- The principal place of business of this corporation shall be 6579 Federal Street, Navarre, Florida 32566, and the mailing address shall be P.O. Box 6312, Navarre, Florida 32566.
