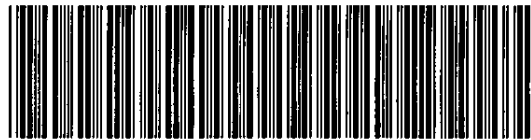



The Articles of Incorporation of "FRIENDS" Respond In Every Need Doing Something, Inc., a Florida not-for-profit Corporation (the "Corporation") which were filed January 16, 2007 and assigned Document No. N07000000445 are hereby amended by restating the following Article:

**ARTICLE III
PURPOSE**

The specific purpose for which this corporation is organized is: A Christian cancer support and bible study group. We will offer spiritual care and support to manage and overcome cancer. This corporation is organized exclusively for charitable religious, educational, and scientific purposes, under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The foregoing amendment was adopted on the 27 day of July, 2007, by all of the directors and stockholders of the Corporation by written consent pursuant to the provisions of Sections 617.0821 of the Florida Statutes.


