

Citizens United to Fight Felons, Inc.

Pursuant to the Chapter 617 Florida Statutes, the undersigned incorporators hereby adopt the following Articles of Incorporation:

Article I

The name of this corporation is Citizens United to Fight Felons, Inc.

Article II

The main office of the corporation is 5073 Vineland Rd., Orlando, FL 32811.

Article III

The purpose of this corporation is to support the police and law abiding citizens in their efforts to protect themselves from crime by using education and providing professional services like paying legal fees.

Anything in these articles of incorporation to the contrary notwithstanding, the purpose or purposes for which this corporation is organized are limited to those that will qualify it as an exempt organization under 26 USCA Section 501(c)(3), including, for those purposes, the making of distributions to organizations that qualify as tax exempt organizations under the Internal Revenue Code.

This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation. This corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

No part of the net earnings, properties, or assets of this corporation, on dissolution or otherwise, shall inure to the benefit of any private person or individual or any member or director of this corporation. On liquidation or dissolution all of the earnings, properties and assets shall

be transferred to an organization that qualifies as exempt under 26 USCA Section 501(C)(3).

Article IV

Directors shall be elected for one year terms by majority vote of the Board of Directors in accordance with the bylaws.

Article V

The number of initial directors of this corporation is three. The name and address of the initial directors are as follows: James Kelley of 5073 Vineland Rd., Orlando, FL 32811, Steve Shaw, P.O. Box 1241, Silver Springs, FL 34489 and Michael Kelley, 121 East Wooster St., Suite 257, Bowling Green, OH 43402.

Article VI

The name and address of the Registered Agent of the corporation is James Kelley 5073 Vineland Rd., Orlando, FL 32811.

Article VII

The name and address of the original incorporator is as follows: James Kelley of 5073 Vineland Rd., Orlando, FL 32811.

Article VIII

The Articles of Incorporation shall be effective when filed. The corporation shall continue to operate until it is dissolved.

Article IX

The sole class of members in this corporation shall be its directors. The members of the corporation shall have no right, title, or interest in its income, property or assets, nor shall any portion of its income, property, or assets be distributed to any member on the dissolution or winding up of this corporation.
