ARTICLE VI Directors

- 1. The business of this Association shall be conducted by a Board of Directors having not less than three (3) nor more than five (5) Directors, the exact number to be determined by the Board from time to time in advance of the annual election. There shall always be an odd number of Directors.
- 2. The election of Directors, their removal or filing of vacancies on the Board of Directors shall be in accordance with the By-Laws of the Association. Directors shall be elected at the annual meeting of the members of the Association by the Developer (if applicable) and by the members, and they shall hold office for a two (2) year term, as provided in the By-Laws, a one (1) year term or until their successors are duly elected. The Developer shall have the right to elect a majority of the Directors until such time as it is required by law to transfer control of the Association to unit owners.
