**ARTICLE I**

**ARTICLE III**

The corporation is organized exclusively as a church and ministry of Trinity Reformed Church, Inc., a registered Florida nonprofit corporation. (No. 732257) The corporation's primary purpose is to proclaim the Gospel of Jesus Christ, as it is defined in the Holy Bible. It may engage in or support any activities necessary or appropriate to fulfill the foregoing purposes, including but not limited to, the exercise of all powers granted by Chapter 617, Florida Statutes. More specifically, the corporation shall assume responsibility for operating the Nicaraguan orphanage, feeding, educational and other ministerial and benevolent programs, which are presently in existence.

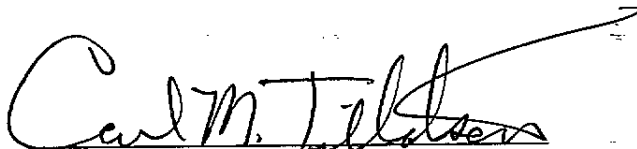
