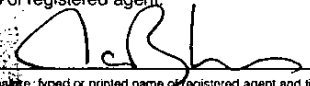

It was determined that a quorum was present, and the following matter of corporate business was transacted.

The first order of business related to the approval of the minutes of the special meeting held on the 24<sup>th</sup> day of August, 2007. UPON MOTION duly made by Charlana Kelly, seconded by Chuck Kelly, and unanimously carried, it was resolved that the minutes were approved.

The second order of business related to the welcoming of Gary Panepinto to the Board of Directors of Renaissance Church Inc.. Gary Panepinto was asked and accepted a position on the board of Renaissance Church prior to the annual board meeting.

The third order of business related to forming a compensation committee for James Wheeler. WHEREAS, the corporation desires to have Charles Kelly, Charlana Kelly, and Gary Panepinto to form the compensation committee; therefore, UPON MOTION duly made, seconded and 4 votes for and 1 abstention made, it was resolved that the corporation has named the above to form the compensation committee for James Wheeler.

The fourth order of business related to the postponement of a third signature on the bank account of Renaissance Church Inc.. WHEREAS, the corporation decided that a third signature was unnecessary at this time, and a \$5,000 limit was to be set for spending without board approval. UPON MOTION duly made, and unanimously carried, it was resolved that there would be no third signature at this time and a \$5,000 spending limit would be established without board approval.

The fifth order of business related to the Treasurer's report, made by Christine Wheeler. It was reported the total donations for the 2007 tax year was \$21,994.62. Renaissance Church Inc., expenditures totaled \$20,207.18, leaving a surplus of \$1,787.44 in the Renaissance Church, Inc. bank account.

Also noted donations for January 2008 totaled \$880.00 with an additional \$100.00 added from a September 2007 bank error posted on 1-16-08. February donations thus far totaled \$2,544.00. The expenses accrued by Renaissance Church in January – February of 2008 is \$2,555.84.

Christine Wheeler noted that donations from church services are always counted with at least two people present for accountability purposes.

Also noted was that Renaissance Church, Inc. is now seeking nonprofit tax-exempt status under 501(c)(3) of the Internal Revenue Code.

The sixth order of business related to the report of progress made by the President, James Wheeler. He reported on the personal journey that had brought him to Clermont to plant a church. Services are now being held at Green Valley Country Club. He spoke of the people God has sent to Renaissance and what a blessing they are. He spoke of the Clermont community and the events Renaissance Church has participated in. He stated that he is grateful but not satisfied. He spoke of the finances for the church and personally asked the board to continue to pray for the ministry. He added that great vision brings great resistance. We are up to the challenge.

There being no further business to come before the meeting, upon motion duly made, seconded, and unanimously carried, the meeting was adjourned.
