ARTICLE I

Name

The name of this Corporation is SOUTH FLORIDA EXTREME BASEBALL TEAM, INC. (hereinafter called the "Corporation").

ARTICLE II

Corporate Nature

The Corporation is a corporation not for profit organized pursuant to the Florida Not For Profit Corporation Act set forth in Chapter 617 of the Florida Statutes (the "Act").

ARTICLE III

Address

The address of the principal office and the mailing address of the Corporation shall be 920 West 84th Street, #209, Hialeah, Florida 33014.

ARTICLE IV

Duration

The period of the duration of the Corporation is perpetual unless dissolved according to law.

ARTICLE V

Purposes

The purposes for which the corporation is organized are (1) to engage in managing youth baseball programs; (2) to transact any lawful business for which a not for profit corporation may be formed pursuant to the Act, and (3) to do such other things as are incidental or desirable in order to accomplish the foregoing

ARTICLE VI

Powers

The Corporation shall have all of the powers, privileges, rights, and immunities necessary or convenient for carrying out the purposes set forth in Article V hereof, and all the benefits, privileges, rights and powers created, given, extended or conferred now or hereafter, by the provisions of all applicable laws of the State of Florida pertaining to corporations not for profit, including any additions or amendments thereto.

ARTICLE VII
Management

All power and authority of the Corporation shall be vested in and exercised by its Board of Directors, which shall manage and direct the affairs of the Corporation in accordance with applicable law and as provided in the bylaws of the Corporation. The number of directors of the Corporation shall be not less than three (3) persons. The number and method of election of directors shall be as stated in the bylaws of the Corporation. The voting and other rights of the members of the Board of Directors shall be as provided in the bylaws of the Corporation, and directors of the Corporation may be assigned different voting rights, including, without limitation, super-voting rights for one or more designated directors.

ARTICLE VIII
Initial Board of Directors

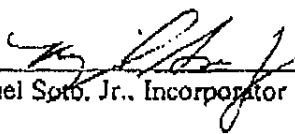

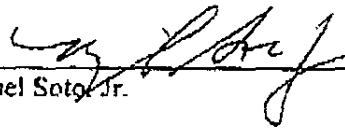
