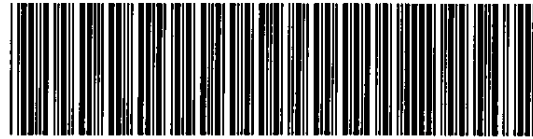

Articles Of Incorporation
Of
MS INS ASSOCIATION, INC.
A NONPROFIT CORPORATION

The undersigned, natural person of the age of eighteen years or older, acting as incorporator for the purpose of creating a nonprofit corporation under the laws of the State of Florida in compliance with Chapter 617, F.S., do hereby set forth:

Article I The name of the corporation is MS Ins Association, Inc.

Article II The principal place of business and mailing address of this corporation is

Article III The purposes for which the corporation is organized are:

MS Ins Association, Inc. is organized for any and all allowable exempt purposes within the meaning of Section 501(c)(15) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Specifically, the organization will provide insurance to members of the association.

No part of the net earnings of the corporation shall inure to the benefit of any director, officer of the corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the corporation, and no officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

Notwithstanding any other provisions of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(15) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article IV The board of directors of the corporation shall be elected or appointed in the manner and for the terms provided in the Bylaws.

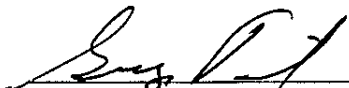

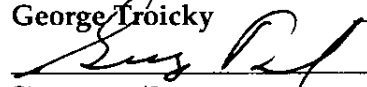
