

ARTICLES OF INCORPORATION OF

ARTICLE I NAME

The name of the corporation is: Plus One Ministries, Inc.

ARTICLE II NONPROFIT CORPORTION

The corporation is a nonprofit corporation. Upon dissolution, all of the Corporation's assets shall be distributed to an organization exempt from taxes under Internal Revenue Code Section 501(c) (3) (or corresponding section of any future Federal Tax code), or shall be distributed to Federal Government or a State of local government for an public purpose.

ARTICLE III PURPOSES

The purposes for which the Corporation is organized are to perform charitable activities within the meaning of Internal Revenue Code Section 501(c) (3) and Chapter 496, F.S. Specifically, the Corporation is organized to encourage and conduct creative forms of prayer and public worship including, but not limited to, the worshipful use of arts and media and to educate members of the public to use prayer, the arts and medial to express themselves in worship. The means of providing such education includes, but is not limited to, maintaining facilities for instruction and public presentations of creative prayer and worshipful arts and media.

ARTICLE IV POWERS

Except as otherwise provided in these Articles, the Corporation shall have all implied powers necessary and proper to carry out its expressed powers. The Corporation may pay reasonable compensation to directors, or officers, for services rendered to or for the Corporation in furtherance of one or more of its purposes set forth above.

ARTICLE V RESTRICTIONS AND REQUIREMENTS

The Corporation shall not pay dividends or other corporate income to its directors or officers or permit the realization of private gain.

The Corporation shall have no power to take any action that would be inconsistent with the requirements for a tax exemption under Internal Revenue Code 501(c) (3) and related regulations, rulings and procedures. The Corporation shall have no power to take any action that would be inconsistent with the requirements for receiving tax deductible charitable contributions under Internal Revenue Code

Section 170(c) (2) and related regulations, rulings and procedures. Regardless of any other provision in these Articles of Incorporation or state law, the Corporation shall have no power to:

- 1. Engage in activities or use its assets in manners that are not in furtherance of or more exempts purposes as set forth above and defined by the Internal Revenue Code and related regulations, rulings and procedures, except to an insubstantial degree.
- 2. Serve a private interest other than one that is clearly incidental to an overriding public interest.
- Devote more than an insubstantial part of its activities to attempting to influence legislation by Propaganda or otherwise, except as provided by the Internal Revenue Code and related regulations, rulings and procedures.
- 4. Participate in or intervene in any political campaign on behalf of or in opposition to any candidate for public office. The prohibited activities include the publishing or distribution of statements and other direct or indirect campaign activities.
- 5. Permit any part of the net earnings of the Corporation to inure to any private individual.
- Carry on an unrelated trade or business except as a secondary purpose relating to the Corporation's primary exempt purposes.

ARTICLE VI MEMBERSHIP

The Corporation shall have no members.

ARTICLE VII BOARD OF DIRECTORS

The qualifications, manner of selection, duties, terms and other matters relating to the Board of Directors (referred to as the "Board of Directors") shall be provided in the bylaws. The initial Board of Directors shall consist of three (3) persons. The number of directors may be increased or decreased by adoption or amendment of the Bylaws. The initial Board of Directors shall consist of the following persons at the following addresses:
