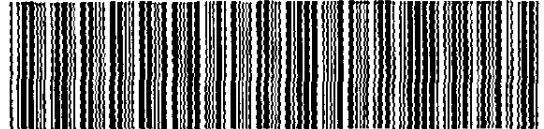

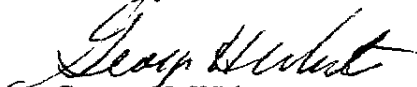

OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles to form a non-profit Corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this Corporation is PANHANDLE MACINTOSH USER GROUP, INC.
