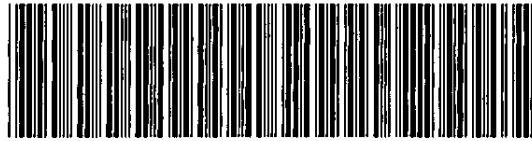



WHEREAS, Pursuant to Article 12. Amendment. The Corporation reserves the right to amend or repeal any provisions contained in the Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Directors, and Officers are subject to this reservation.

WHEREAS, the Members, Directors and Officers wish to change the name of the Corporation by this First Amendment as follows:

Article 1. Name. Is hereby revoked in its entirety and this new Article 1. Name shall replace same thereto.

Article 1. Name. The name of the Corporation is: **Doris C. Rosenblatt and Frank L. Rosenblatt Family Foundation, Inc.**
