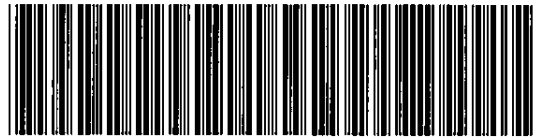

# **ARTICLES OF INCORPORATION Of**

## **Lincoln Lacrosse Boosters, Inc.**

In Compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I - NAME**

The name of the corporation shall be Lincoln Lacrosse Boosters, Inc.

### **ARTICLE II - PRINCIPAL OFFICE**

The principal place of business of this corporation shall be c/o Athletic Director, Lincoln High School, 3838 Trojan Trail, Tallahassee, FL, 32311-3810, but it shall have the power to transact business in any other place or places both within and without the State of Florida and throughout the world. The mailing address of the corporation shall be c/o Sam McArthur, 1620 Highland Drive, Tallahassee, FL 32317.

### **ARTICLE III - PURPOSE**

The corporation is organized exclusively for the charitable, educational, and scientific advancement of the Lincoln High School Lacrosse Program within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

### **ARTICLE IV - MANNER OF ELECTION**

The manner in which the directors are elected or appointed shall be as stated in the bylaws.

### **ARTICLE V - INITIAL DIRECTORS AND/OR OFFICERS**
