**ARTICLES OF INCORPORATION
OF
Florida Red Tide Solutions, Incorporated**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **Florida Red Tide Solutions, Incorporated**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
456 Beverly Rd., Venice, Florida 34293

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: Designation to be Charitable /Scientific. The corporation will actively address the red tide issue in the Gulf Coast area, off of Florida, first by exploring all causes, and next independently testing all known solutions.... with the intent being to ethically, morally and rationally choose the least harmful solution/treatment for the gulf coast; in order to 'short term' quell the destruction that has effected our state and health. At the same time to investigate viable solutions to lesson the main source of these harmful algal blooms, the wastewater and fertilizer dump into our waters through viable fertilizing alternatives for our community land and businesses.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
