ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: MUSLIM CHAMBER OF COMMERCE OF FLORIDA, INC.

ARTICLE II

The street address of the principal office of the Corporation is: 10376 E. Colonial Dr, Suite 108, Orlando, FL 32817.

ARTICLE III

The Corporation is a not for profit corporation under the provisions of Chapter 617, Florida Statutes.

(a) No part of the earnings of the Corporation shall inure to the benefit of, or be distributed to the corporation's members, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered.

(b) Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by a Corporation exempt from Federal income tax under Section 501(c)(6) of the Internal Revenue Code, as amended.

ARTICLE IV

ARTICLE V
