Article of Incorporation for Creole Publishing, Inc.

In Compliance with Chapter 617 F.S. Not for Profit

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify that:

Article I (Name)

1.01. The name of the Corporation shall be Creole Publishing, Inc.

Article II (Principal Office)

2.01. The principal place of business and mailing address of Creole Publishing Inc. shall be at 4111 Woodside Dr. #3, Coral Springs, FL 33065.

Article III (Purpose)

- 3.01. Creole Publishing, Inc. is a non-profit organization dedicated to the production, publication, and presentation of high-quality artistic and cultural expressions for the multi-ethnic community of South Florida. The purpose for, which the corporation is organized is to (1) celebrate diversity and arts excellence; (2) nurture and develop the talents of young artists; (3) extend the reach of arts and promote literacy in underserved communities; (4) encourage dialogue and cooperation between cultures; and (5) generate provocative ideas and provide new ways of looking at persistent social problems.
- 3.02. Further said corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- 3.03. Further said corporation is organized to have and exercise all rights and powers conferred on nonprofit corporations under the laws of Florida, or which may hereafter be conferred, including the power to contract, rent, buy, or sell personal or real property; provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.
- 3.4. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
