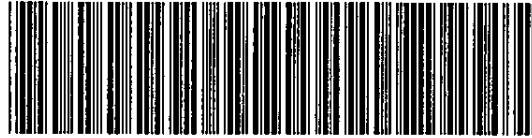

ARTICLE III PURPOSE

The specific and primary purpose for which this non-profit corporation is formed is to assist needy children in the country of Colombia, SA to help them obtain an education and to provide basic needs for their daily life.

The general purposes for which this corporation is formed are to operate exclusively for such educations and assistance purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations qualifying as tax-exempt organizations under that Code.

This corporation shall not, as a substantial part of its activities, carry out propaganda or otherwise attempt to influence legislation; not shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE IV MANNER OF ELECTION
