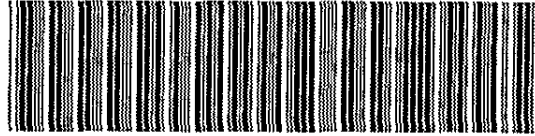


**ARTICLE VIII DISSOLUTION**
