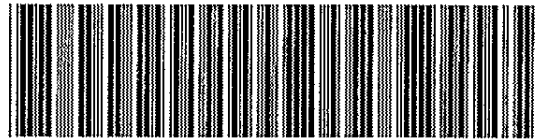

The undersigned, acting as incorporator(s) pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such corporation.

Article I

The name of the corporation is: Gentle Hugz Childcare, INC, and it's principal address of the corporation is: 2729 Northwest 6th Street, Pompano Beach, Florida 33069.

Article II

The Period of duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

Article III

The purpose for which the corporation is organized is formed solely for childcare purposes, for charitable, scientific, literary, and educational, with the meaning of Section 501 (c) (3) of the Internal Revenue Code. No substantial part of the activities of the organization shall be carrying on the propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities permitted to be carried on by an organization Exempt from the Federal Income Tax under Section 501 (c) (3) of the present Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law. No part of the net earning of the corporation shall inure to the benefits of, or be distributions in furtherance of Section 501 (c) (3) purpose.

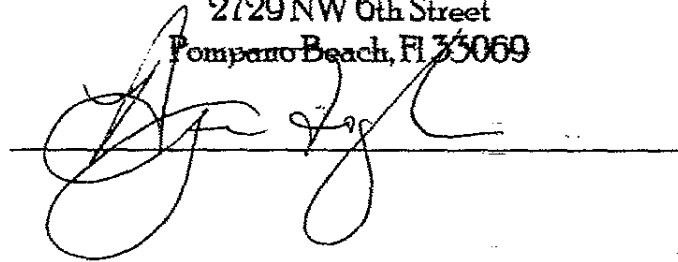

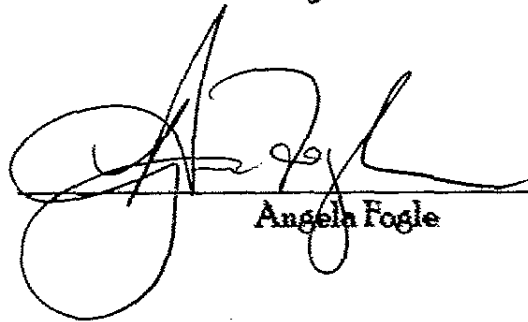
Article IX
