Notwithstanding any other provision Visionaries Dance Ministry, Inc. will not carry on any other  
activities not permitted to be carried on by an Organization exempt from Federal Income Tax  
under section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provisions  
of any future United States Internal Revenue Law.


