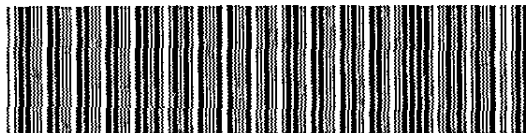

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To conduct permitted voluntary marine sea turtle monitoring activities on Alligator Point, Florida for Marine turtle Permit (MTP) #151 as authorized by the Florida Fish and Wildlife Conservation Commission's (FFWCC) Division of Habitat and Species Conservation. Permitted activities include: (1) conducting nesting surveys, (2) conducting stranding and salvage activities, (3) screening nests with self-releasing screens or cages, (4) maintaining and displaying preserved specimens, and (4) conducting authorized amended activities.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Sea turtle patrollers who are listed on Marine Turtle Permit (MTP) #151 are required to attend and successfully complete a FFWCC conducted workshop which qualifies them to be appointed as a volunteer board of director member for the Alligator Point Sea Turtle Patrol, Inc. The holder of MTP #151 serves as the Director and appoints qualified members to the Board of Directors for the Alligator Point Sea Turtle Patrol, Inc.
