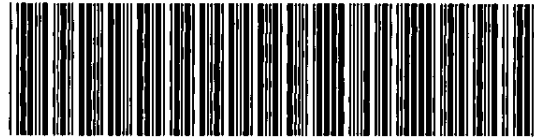

**ARTICLE I**

This corporation is organized and incorporated pursuant to the Florida Not For Profit Corporation Act, Chapter 617, F.S.

**ARTICLE II**

The name of the corporation shall be **United Torah Education & Scholarship Fund, Inc.**

**ARTICLE III**

The principal place of business and mailing address of the corporation is 7505 London Lane, Boca Raton, Florida 33433.

**ARTICLE IV**

The purposes for which the corporation is organized are exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue. These purposes shall primarily include, but not be limited to, the raising and distribution of charitable funds to yeshivas and other organizations that provide for, or enhance, Torah education among young Jewish adults, including the provision of scholarship funds for the needy to attend yeshivas and other Torah centers and the reprinting and dissemination of classic Orthodox Jewish texts of halachic and aggadic content for scholastic and Torah education purposes.

**ARTICLE V**

This corporation shall be a non-member organization.

**ARTICLE VI**

Upon the dissolution of the corporation, its remaining assets, if any, shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such

purposes.

#### **ARTICLE VII**

No portion of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

#### **ARTICLE VIII**

No substantial plan of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

#### **ARTICLE IX**

The number of directors and the manner in which the directors of the corporation shall be elected or appointed are as follows: The Board of Directors shall consist of three persons, who shall be appointed annually by the Board members of the previous term at the last meeting of their annual term that shall be held during the month of January commencing in 2008. The number of officers and the manner in which the officers of the corporation shall be elected or appointed are as follows: The Officers shall consist of three persons, to wit, president, vice president and secretary-treasurer, who shall be appointed annually by the Board members of the previous term at the last meeting of their annual term that shall be held during the month of January commencing in 2008. The manner of election of the directors is as stated in the bylaws.

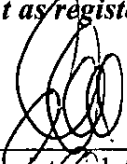

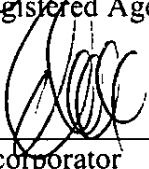
