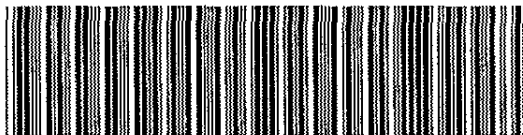

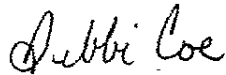

ARTICLES OF INCORPORATION
OF
SOUTHWEST FLORIDA CHRISTIAN COMMUNITY SCHOOL, INC.

ARTICLE I – Name

The name of the Corporation Southwest Florida Christian Community School Inc.

ARTICLE II – Principal Office

The place in this state where the principal office of the Corporation is to be located is the City of Fort Myers, Florida, Lee County. The mailing address shall be: 8724 Crest Lane, Fort Myers, Florida 33907

ARTICLE III – Purpose

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

In fulfilling its purposes, the Corporation shall admit students of any race, color, national and ethnic origin. The Corporation shall not discriminate on the basis of race, color, or national or ethnic origin in the administration of its admission policies, educational policies, scholarship and/or loan programs, and athletic and other Corporation-administered programs.

ARTICLE IV – Manner of Election

The Corporation shall have voting members, who shall be elected (and may be removed) by the voting members and who shall have all the rights and privileges of members of the Corporation. The election of such members, as well as the time and place for holding special and annual meetings, shall be as provided in the By-laws of the Corporation.

ARTICLE V – Initial Board of Directors

The initial Board of Directors shall have three members whose names and addresses are:

The By-Laws shall provide the method of election of all directors, and the number of directors may be raised or lowered by amendment of the By-Laws but shall in no case be less than three.

ARTICLE VI – Officers

The officers of the Corporation shall consist of a President, Vice-President, Secretary and Treasurer. Other officers may be provided for in the By-Laws. Each officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the By-Laws.

ARTICLE IX – Non-Profit Status

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

In the event that the Corporation is characterized as a private foundation within the meaning of Section 509 of the Internal Revenue code during any period, the Corporation, during such period:

Shall distribute its income for each taxable year at such time and in such manner as not to become subject to tax on undistributed income imposed by Section 4942 of the Internal Revenue Code;

Shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code;

Shall not retain any excess business holdings as defined in Section 4943(c) of the internal Revenue Code;

Shall not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code; and

Shall not make any taxable expenditure as defined in Section 4945 of the Internal Revenue Code.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE X – Distribution of Assets Upon Dissolution

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

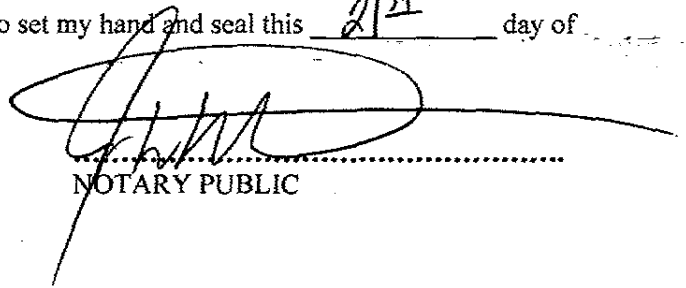
