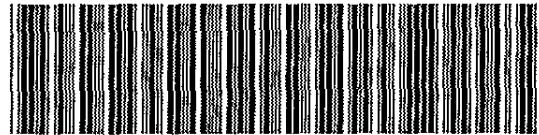

AMENDMENTS ADOPTED

Article One. Purpose.

Section One. Need to add the following:

The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under Internal Revenue Code section 501 © (3) or corresponding section of any future federal tax code.

Article One. Purpose.

Section Two. Need to add the following:

No part of the organization's assets will inure to the benefit of any private individual. No substantial part of the activities may include carrying on propaganda or otherwise attempting to influence legislation (except as provided for in subsection 501 (h)), or participation in or intervening in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office. The purposes may include the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this organization, assets will distributed for one or more exempt purposes within the meaning of Internal Revenue Code section 501 © (3), or corresponding section of any future federal tax code, or will be distributed to the federal government, or to a state or local government for a public purpose.


