

ONE:

The name and address of this principal corporation is Pamela Brown Ministries, Inc. 7943 NW 14th Court, Miami, Florida 33147, in Miami-Dade County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO:

This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for, Religious and Charitable purposes.
