ARTICLE I.

The name of this corporation is BASS HARBOUR CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 223 Taylor Street, Punta Gorda, Florida 33950, and the initial mailing address of the corporation is 223 Taylor Street, Punta Gorda, Florida 33950.

ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the proposed Bass Harbour, a Condominium, located in Charlotte County, Florida, and to operate property owned by the Association.
