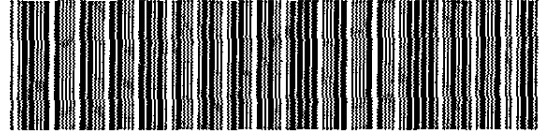

This corporation shall commence to exist on the date of filing.



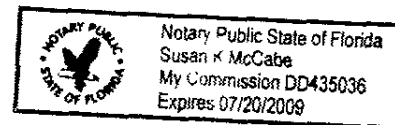
