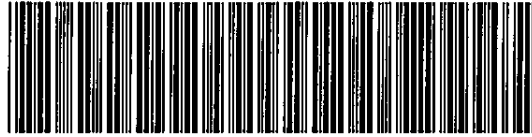

**ARTICLE I**

Name

Purposes

The purpose for which the corporation is organized is:

The Miramar Patriots football Booster Club, Inc. is organized exclusively for charitable, educational and developmental growth purposes of the Miramar High School football teams to include boys' Junior Varsity, Varsity & girls' Flag Football.

- a) The primary purpose for which this corporation is formed to contribute financially, emotionally, spiritually and provide advance educational support to the schools football athletic program. Such method of achieving purpose goals will be primarily by fundraising and charitable donations.
- b) No part of the net earnings of the corporation shall inure to the benefit of any private individual. No substantial part of ties' activities will be carrying out propaganda or otherwise attempting to influence legislation. The corporation will not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Upon dissolution, all assets of the corporation will be distributed to organizations exempt under Internal Revenue Code section 501 ( c )(3), or by an organization, contributions to which are deductible under Internal Revenue Code section 170 ( c )(2), or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose . Notwithstanding any other provision of these articles, this corporation shall not except to an insubstantial degree engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

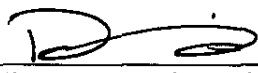

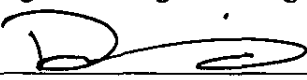
