

**ARTICLES OF INCORPORATION
OF
EVERYONE'S UNIQUE LEARNING CENTER, INC.**
A Florida Non-Profit Corporation

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a non-profit corporation under the Florida Business Corporation Act (the "Act"), pursuant to Chapter 617 .0202, Florida Statutes and adopts the following Articles of Incorporation.

ARTICLE I
Corporate Name

The name of the corporation shall is Everyone's Unique Learning Center, Inc.

ARTICLE II
Principal Address

The principal place of business and mailing address of the corporation is 3008 E. 27th Avenue, Tampa, FL 33605.

ARTICLE III
Purpose

The purpose for which this corporation is organized is solely and exclusively charitable, religious, educational, literary and scientific within the meaning of Section 501(c)(3) of the Internal Code as follows:

- A. To inform, teach and mentor at risk, inner-city youths and adults by establishing "support group" fellowships to address such issues as: addictions, physical and sexual abuse, teenage pregnancy and illiteracy as a primary means of ministering to those that are evangelized.
- B. To provide an outreach ministry community center that equips youths and adults with skills to make a living and a spiritual foundation to make a better life.
- C. To render aid and assistance to youths and adults where possible in an effort to reduce the rate of recidivism in the criminal justice system.
- D. To provide job-training and assistance to economically disadvantaged adults.
- E. To engage in any lawful business or activities related to the aforementioned charitable, religious, educational, literary and scientific purposes.
