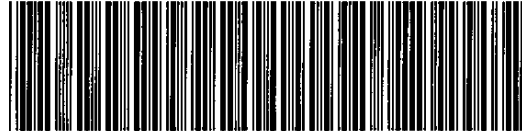

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Mission Statement – The National Association of Dental Laboratories, Inc. (NADL) is the unified voice for the dental laboratory industry supporting dentistry and serving the public by promoting high standards. NADL accomplishes this by providing programs, services, and networking opportunities responsive to the evolving technical, educational, professional and business needs of dental laboratories.

Vision Statement – NADL shall be the pre-eminent voice for the dental laboratory industry to ensure professionalism through strategic leadership, partnering and cohesive representation before regulatory and educational entities. NADL shall guide the industry by setting standards and providing a venue for members to advance in the field of dental technology.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The elective officers of the Association shall include a President, President-Elect, and twelve other directors. The President-Elect shall be elected at the Annual Meeting of the members, or by mail ballot, for one (1) year, commencing no later than January 1 following the election. The President-Elect shall succeed to the office of President without other election at the next Annual Meeting of the members following election as President-Elect. Elective officers shall not be paid a salary. A vacancy in any elective office, because of death, resignation, removal, disqualification, or otherwise, shall be filled by an automatic succession to the vacancy by the next elected officer in line, and, if after this automatic succession a vacancy still exists, the vacancy may be filled by the President with the approval of the Board of Directors for the unexpired portion of the term. In the event of temporary inability to serve on the part of an elective officer, the President, with the approval of the Board of Directors, shall appoint a substitute to act during such temporary inability to serve. In the event the offices of President and President-Elect are vacant, so that the latter is unable to fill the vacancy in the office of President, the Board of Directors shall, by a majority vote, fill the vacancy in the office of President.
