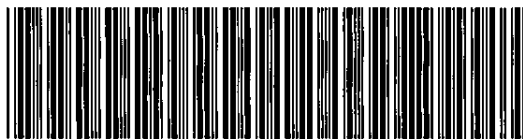

**ARTICLES OF INCORPORATION
OF
Vero Beach Swim, Inc.
A Florida "Not for Profit" Corporation**

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

NAME OF CORPORATION: The name of the corporation is Vero Beach Swim, Inc.

PRINCIPAL OFFICE: The principal office of the corporation is located at 2445 18th Street, Vero Beach, FL 32960.

MAILING ADDRESS: The mailing address of the corporation is 2445 18th Street, Vero Beach, FL 32960.

REGISTERED AGENT: The name of the registered agent of the corporation is Adam Bolinger. The address of this registered agent is 2006 Surfside Ter., Vero Beach, FL 32963.

DURATION: The period of duration is perpetual, and the corporation existence will commence with the filing of these Articles by the Department of State.

MEMBERSHIP: Unless otherwise provided in the Corporation's Bylaws, the Corporation shall not have any members, and shall be considered a non-membership organization.

BOARD OF DIRECTORS: The method of selection of the Board of Directors and number of directors shall be stated in the bylaws.

CORPORATE PURPOSES

The purposes for which this corporation is formed is for charitable and educational purposes and for the purpose of fostering national and international amateur sports competition, and any business permitted under the laws of the United State and the state of Florida.

1. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to any member, trustee, director, or officer of the Corporation, or any private individual (except reasonable compensation may be paid for services rendered to or for the benefit of the Corporation), and no member, trustee, director, or officer of the Corporation or any private individual shall be entitled to

share in the distribution of any of the Corporation assets on dissolution of the Corporation.

2. No substantial part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by Internal Revenue Code Subsection 501 (h)], or participating in, or intervening in [including the publication or distribution of statements], any political campaign on behalf of any candidate for public office.
3. Notwithstanding any other provision of these articles, the Corporation shall not carry on any activities not permitted to be carried on (i) by a corporation exempt from Federal income tax under Subsection 501 (c)(3) of the Internal Revenue Code of 1986 or (ii) by a corporation contributions to which are deductible under Subsection 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
4. In the event of the liquidation, dissolution, or winding up of the Corporation, whether voluntary or involuntary or by operation of law, all of the remaining assets and property of the Corporation shall, after necessary expenses thereof, be distributed to such organizations as shall qualify under Subsection 501(c)(3) of the Internal Revenue Code of 1986, as amended.
5. Any other provisions herein notwithstanding, no member, trustee, director, officer, or private individual shall engage in any act of self-dealing as defined in Subsection 4941 of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws; nor failure to distribute an amount of income required to avoid incurring tax liability under subsequent federal tax laws; nor make any taxable expenditures as defined in Subsection 4945 of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

INDEMNIFICATION

Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he is or was a Director or Officer of the Corporation shall be indemnified by the Corporation against any and all liability and the reasonable expenses, including attorney's fees and disbursements, incurred by him (or by his heirs, executors or administrators) in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such Director or Officer is liable for negligence or misconduct in the performance of his duties. Such right of indemnification shall not be deemed exclusive of any other rights to which such Director or Officer (or such heirs, executors or administrators) may be entitled apart from this Article.

These Articles of Incorporation are hereby executed by the incorporator on this 10th day of January, 2007.

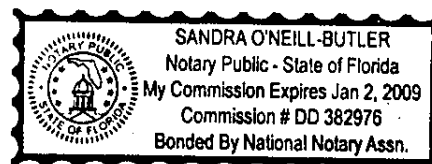
