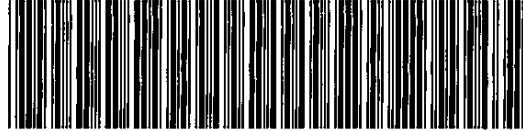

ARTICLES OF INCORPORATION
OF THE BELLALAGO ACADEMY PTO, INC.

TO: DEPARTMENT OF STATE, DIVISION OF CORPORATIONS:

The undersigned natural person of the age of twenty-one years or more, acting as incorporator, adopts the following Articles of Incorporation pursuant to the State Nonstock Corporations Act:

- FIRST: The name of the organization is BELLALAGO ACADEMY PTO, INC.
- SECOND: The Principal place of business and mailing address of the organization is 3651 Pleasant Hill Road, Kissimmee, FL 34746.
- THIRD: The organization is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) Specifically, the organization is organized to support the education of the children at Bellalago Academy by fostering relationships between the school, parents and teachers. In pursuance of these purposes it shall have the powers to carry on any business or other activity which may be lawfully conducted by an organization organized under the State of Florida. Nonstock Corporations Act, whether or not related to the foregoing purposes, and to do all things necessary, proper and consistent with maintaining tax-exempt status under section 501(c)(3).
- FOURTH: The period of duration is perpetual.
- FIFTH: The organization may have one or more classes of members, the qualifications and rights, including voting rights, of which shall be designated in the Bylaws.
- SIXTH: The number of directors constituting the initial Board of Directors is five, and the names and addresses, including street number, of the person who are to serve as the initial directors until the first annual meeting, or until their successors are elected and qualified are:

The members of the Board of Directors shall be those individuals elected, from time to time, in accordance with the Bylaws. Directors shall elect their successors.

SEVENTH: The registered agent is Aracely Lopez Rodriguez, who is a resident of the State of Florida and a director of the organization, and the address of its initial registered office is 3651 Pleasant Hill Road, Kissimmee, FL 34746, which is physically located in the County of Osceola.

EIGHTH: The internal affairs of the organization shall be regulated by its Board of Directors as described in the Bylaws. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes with the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

NINTH: No part of the net earnings of the organization shall inure to the benefit of or be distributed to any director, employee or other individual, partnership, estate, trust or organization having a personal or private interest in the organization. Compensation for services actually rendered and reimbursement for expenses actually incurred in attending to the affairs of this organization shall be limited to reasonable amounts. No substantial amount of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and this organization shall not intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles or of any Bylaws adopted thereunder, this organization shall not take any action not permitted by the laws which then apply to this organization.
