AMENDMENT TO THE ARTICLES OF INCORPORATION OF SAWGRASS PLANTATION PHASE 1A TOWNHOME ASSOCIATION, INC.

WHEREAS, that certain Declaration of Covenants and Restrictions for Sawgrass Plantation Phase IA Townhome Association is recorded at Official Records Book 9163, Page 4176, Public Records of Orange County, Florida as amended and supplemented from time to time ("Declaration"); and

WHEREAS, the Articles of Incorporation of Sawgrass Plantation Phase 1A Townhome Association, Inc. are recorded as Exhibit "B" to the Declaration at Official Records Book 9163, Page 4215, Public Records of Orange County, Florida ("Articles"); and

WHEREAS, Article X of the Articles states that an Amendment of these Articles shall require the approval by a majority vote of the Board; and

WHEREAS, the Board of Directors desire to amend the Articles reducing the number of Board of Directors from five (5) Directors to three (3) Directors; and

WHEREAS, the necessary vote was obtained pursuant to Article X of the Articles.

NOW, THEREFORE, pursuant to the amendment procedures set forth in Article X of the Articles, the following Amendments are hereby adopted:

- Article VII, Section A. Paragraph 1 of the Articles is hereby amended to read as follows:
 - A. Board of Directors: Selection: Terms of Office. The affairs of the Association shall be managed by a Board of Directors. A director need not be a Member of the Association. The initial Board shall consist of five (5) three (3) Directors, who shall be selected by the Declarant.
- 2. Article VII, Section A, Paragraph 5 of the Articles is hereby amended to read as follows:

There shall-be elected one-Director-from a term-of-one-year-one-Director-for-a term-of-two-years-two-if-Declarant is not-enabled to appear to Director and two Directors for a term of three-years-At-each annual meeting thereafter-the-Members shall elect the same number of Directors is those who terms expired Directors shall be elected to serve terms of three (3) years. The Board shall implement staggered terms in such a manner as to have as nearly gapad in number as possible the number of Directors whose terms expire in any given year, including in the event that the number of members of the Board is changed.
