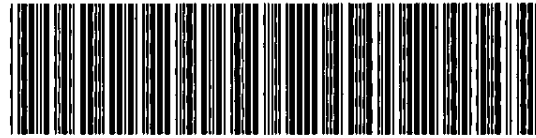

SECOND: The document number of the Corporation is N07000001743.


THIRD: The file date of the Articles of Incorporation is February 16, 2007.
