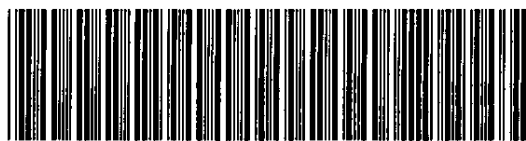

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Christ for Kinshasa Ministries Inc.

ARTICLE II PRINCIPAL OFFICE
