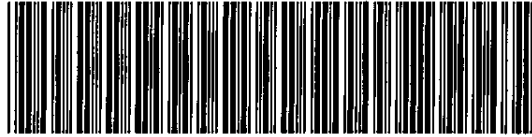

ARTICLE I NAME

ARTICLE III PURPOSE

This corporation is intended to continue in perpetuity. In the unlikely event that the club is dissolved, all monies and property owned by the club shall be donated to an Environmentally-friendly organization to be decided upon at that time by a majority of the officers and the board of directors.
