

# ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S.; (Not for Profit)

#### Article I

The name of this corporation shall be, "Reborn The Bible Way Outreach Ministry, Inc." It shall be incorporated as a not for profit religious organization under the laws of the State of Florida.

#### Article II

The principal place of business and mailing address of this corporation shall be 1024 Susan Drive, in the city of Lakeland, County of Polk, 33803. The registered agent in the charge thereof is Pastor Willie J. McCoy of "Reborn The Bible Way Outreach Ministry, Inc." located at 1024 Susan Drive, Lakeland, Fl. 33803.

#### Article III

The purpose for which the corporation is organized is:

- 1. To encourage and promote the evangelization of the gospel of Jesus Christ throughout the world.
- 2. To encourage and promote the worship of God
- 3. To encourage and promote the edification of believers
- 4. To provide a basis of fellowship among Christians of like faith
- 5. To supervise all the activities of "Reborn The Bible Way Outreach Ministry, Inc."
- 6. To establish churches and encourage their development
- 7. To examine candidates for the ministry and to ordain as ministers those who are approved by God and meet the requirements of this fellowship.
- 8. To approve all scriptural teachings and conduct, and to disapprove all unscriptural teachings and conduct. The Board of Directors shall be expected to keep vigilant watch against any violation of the principles of spiritual unity and cooperative fellowship to which the Bible Way Outreach Ministry is dedicated.

#### STATEMENTS OF FUNDAMENTAL TRUTHS

# Section 1 - The Scriptures Inspired

The scriptures, both Old and New Testaments, are verbally inspired of God and are the revelation of God to man, the infallible, authoritative rule of faith and conduct (II Timothy 3:15-17; I Thessalonians 2:13; II Peters 1:21).

# Section 2 - The One True God

(Deuteronomy 6:4; Isaiah 43:10,11; 44:24; Matthew 28:19) We honor the son even as we honor the Father.

(Luke 3:22); (John 5:22, 23; Revelations 5:6-14; Philippians 2:8,9)

#### Section 3 - The Deity of the Lord Jesus Christ

The Lord Jesus Christ is the eternal Son of God. The scriptures declare:

- 1. His virgin birth (Matthew 1:23; Luke 1:31,35).
- 2. His sinless life (Hebrews 7:26; 1 Peter 2:22).

- 3. His miracles (Acts 2:22; 10:38).
- 4. His substitutionary work on the cross (I Corinthians 15:3; II Corinthians 5:21).
- 5. His bodily resurrection from the dead (Matthew 28:6; Luke 24:39; I Corinthians 15:4).
- 6. His exaltation to the right hand of God (Acts 1:9, 11; 2:33; Philippians 2:29-3:11; Hebrews 1:3).

#### Section 4- The Fall of Man

Man was created good and upright; for God said, "Let us make man in our image after our likeness." However, man by voluntary transgression fell and thereby incurred not only physical death but also spiritual death, which is separation from God (Genesis 1:26, 27; 2:17; 3:6 Romans 5:12-19).

## Section 5 - The Salvation of Man

Man's only hope of redemption is through the shed blood of Jesus Christ the Son of God.

1. Conditions of Salvation

Salvation is received through repentance toward God and faith toward our Lord Jesus Christ. By the washing of regeneration and renewing of the Holy Ghost, being justified by grace through faith, man becomes an heir of God according to the hope of eternal life (Luke 24:47; John 3:3; Romans 10:13-15; Ephesians 2:8; Titus 2:11; 3:5-7).

2. The Evidence of Salvation

The inward evidence of salvation is the direct witness of the Spirit (Romans 8:16; Acts 10:45-46) outward evidence to all men is a life of righteousness and true holiness (Ephesians 4:21-24; Titus 2:12).

#### Section 6 - The Ordinance of the Church

1. Baptism in Water

The ordinance of baptism defined in the scriptures. All who repent and believe on Christ as Savior and Lord are to be baptized. Thus they declare to the world that they have died with Christ and that they also have been raised with Him to walk in newness of life. With the Baptism of The Holy Ghost comes such experiences as an overflowing fullness of the Spirit (John 7:37-39; Acts 4:8) a deepened reverence for God (Acts 2:43; Hebrews 12:28), and a more active love for Christ, for His word and the Lost (Mark 16:20).

#### Section 8 - Sanctification

Sanctifications is an act of separation from that which is evil, and of dedication unto God (Romans 12:12; I Thessalonians 5:23; Hebrews 13:13). The scriptures teach a life of "holiness without which no man shall see the Lord." (Hebrews 12:14). By the power of The Holy Ghost we are able to obey the command, "Be ye Holy, for I am Holy." (I Peter 1:15,16). Sanctification is realized in the believers by recognizing our individual identification with Christ in His death and resurrection, and by faith reckoning daily upon the fact of that union, and by offering every faculty continually to the dominion of the Holy Spirit. (Romans 6:1-11,13; Galatians 2:20; I Peter 1:5; Philippians 2:12-13).

## Section 10 - The Final Judgment

There will be a final judgement at which the wicked dead will be raised and judged according to their works. Whosoever is not found written in the Book of Life, together with the devil and his angels, the beast and the false prophet will be assigned to everlasting punishment in the lake which burneth with fire and brimstone, which is the second death (Matthews 25:46; Mark 9:43-48; Revelation 19:20; 2:11-15; 21:8).

# Section 11- The New Heavens and the New Earth

We, according to His promise, look for new heavens and a new earth wherein dwelleth righteousness (II Peter 3:13; Revelation 21:22).

# **Article IV**
