Articles of Incorporation The AMMO Chiefs Association, Inc.

Article I: The name of the corporation shall be the "The AMMO Chiefs Association, Inc.", hereinafter referred to as the Association and/or the ACA. The Association is a not-for-profit corporation incorporated under Chapter 617 of the Florida Statues.

Article II: The principal place of business of "The AMMO Chiefs Association, Inc.", is Ocala, Florida. The mailing address is: AMMO Chiefs Association, 8585 SW SR200 Suite 4, #3, Ocala, Florida 34481

Article III: The purpose of the AMMO Chiefs Association, Inc is primarily social in nature by facilitating camaraderie amongst AMMO Chiefs.
