## ARTICLES OF INCORPORATION OF ASSOCIATION OF PAKISTANI AMERICANS OF CENTRAL FLORIDA, INC.

In Compliance with Chapter 617, F.S. (Not for Profit)

The undersigned incorporator, in order to form a non-profit corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

ONE: The name of this corporation is:

Association of Pakistani Americans of Central Florida, Inc.

TWO: The name and address of the registered agent of this corporation is:

Zubair S. Mansori, CPA, Attorney 863 Cynthianna Circle, Altamonte Springs, Florida, 32701 Principal address 6431 Chathamview Ct. Winder mere, FL. 34786

THREE: The specific purpose for which this organization is established is to provide a focus at cultural and charitable activities of the American community of Pakistani descent and to promote the social and cultural heritage of its members for their benefit as well as for inter faith understanding in general.

The corporation shall be authorized to perform any and all other work which it may lawfully be able to perform in order to promote these charitable purposes.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(C)(3) of the Internal Revenue Code,, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501@(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

FOUR: The affairs of the corporation are to be managed by a Board of Directors, which shall meet at least quarterly to conduct the affairs of the corporation. The corporation shall have a minimum of three directors. The initial directors of the corporation shall be as follows:

- 3. Aniq Shaikh, M.D., Treasurer7824 Lake Underhill Rd, Ste A, Orlando, Fl 32822

The manner in which the directors are elected or appointed is as provided in the Bylaws.

FIVE: The name and address of the incorporator of this corporation is: Zubair S. Mansori, CPA, Attorney, 863 Cynthianna Circle, Altamonte Springs, Florida 32701

SIX: The period of duration of this corporation is perpetual.

SEVEN: The Corporation shall not have corporate members.

EIGHT: The bylaws of the corporation shall be written, amended or rescinded by a 2/3rd majority vote of the Board of Directors.

NINE: Any additional provisions for the operation of the corporation are as follows:

Upon dissolution of this corporation, its assets remaining after payment or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501© (3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501©(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170©(2) of the Internal Revenue Code.

In any taxable year in which this corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code, the corporation 1) shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Internal Revenue Code; 2) shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code; 3) shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code; 4) shall not make any investments in such manner as to subject the corporation to tax under Section 4944 of the Internal Revenue Code; and 5) shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.
