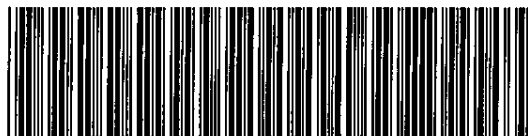

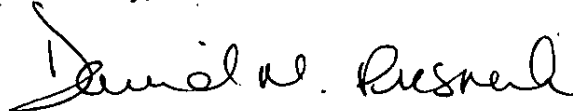

**ARTICLES OF INCORPORATION OF  
GIANT LEAP LEARNING CENTER, INC.**

(A Corporation Not for Profit)

WE, the undersigned residents of the State of Florida, being eighteen (18) or more years of age, do hereby associate ourselves together for the purpose of forming a corporation not for profit, under the laws of the State of Florida, pursuant to the following Articles of Incorporation:

**ARTICLE I**

**Name**

The name of this corporation is: **GIANT LEAP LEARNING CENTER, INC.**

**ARTICLE II**

**Principal Office**

The mailing and street address of the principal office of the corporation is 3925 Grissom Parkway, Cocoa, Florida 32926-3669. The name of the initial registered agent of the corporation at that address is PETRA CRAIG.

**ARTICLE III**

**Statement of Corporate Nature**

This corporation is organized exclusively for providing a day care opportunity for children which will follow a Christian curriculum.

**ARTICLE IV**

**Duration**

The period of duration of this corporation not for profit shall be perpetual.

## **ARTICLE V**

### **General and Specific Purposes**

The specific and primary purposes for which this corporation is formed is to operate a day care facility which teaches a Christian curriculum to the children.

## **ARTICLE VI**

### **Member corporation**

This corporation shall be a non-member corporation.

This corporation shall be non stock and no dividends or pecuniary profits shall be declared or paid to the members thereof.

##### **Dissolution**

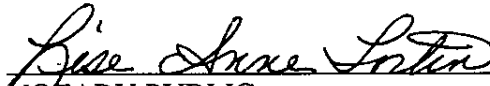

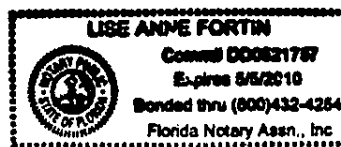
