The undersigned incorporator, a resident of the State of Florida and of full age, hereby makes, subscribes, acknowledges and files with the Department of State of Florida these Articles of Incorporation for the purpose of forming a not-for-profit corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is **PASCO OWNERS FOR LAWFUL EXACTIONS, INC.**, a Florida not-for-profit corporation (hereafter called the "Corporation" in these Articles).

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation is 500 E. Kennedy Boulevard, Suite 200, Tampa, Florida, 33602.

ARTICLE III

PURPOSE

This Corporation does not contemplate pecuniary gain or profit to its members and no part of any net earnings may inure to the benefit of any member or other individual. The purpose for which the Corporation is organized is to create a business league whose purpose shall be to facilitate and promote the interests of contractors, builders, landowners, and other real estate professionals doing business in Pasco County, Florida.




