The undersigned incorporator, a resident of the State of Florida and of full age, hereby makes, subscribes, acknowledges and files with the Department of State of Florida these Articles of Correction to the Articles of Incorporation of Pasco Owners For Lawful Exactions, Inc. pursuant to the provisions of Section 617.0124, Florida Statutes:

1. The document being corrected by this instrument is the original Articles of Incorporation of Pasco Owners for Lawful Exactions, Inc. filed with the Secretary of State of Florida on February 20, 2007, assigned document number N07000001824.

2. The original Articles of Incorporation for Pasco Owners for Lawful Exactions, Inc. contained incorrect statements at Articles IV (Directors and Manner of Election) and Article V (Initial Directors and/or Officers) in which the number of directors of the corporation was inaccurately stated.

3. The Articles of Incorporation for Pasco Owners for Lawful Exactions, Inc. are hereby corrected by deleting in their entirety original Article IV and Article V and inserting in lieu thereof the following:

### ARTICLE IV DIRECTORS AND MANNER OF ELECTION


