Upon examination of the State records June 22, 2009 I learned I was listed as an officer in the subject corporation.

I am resigning from the subject corporation first because I never agreed to be a member or officer of the corporation and most important as an owner of a condominium within the subject center the other two officers, Michael Bagdonas and Moises Solano, ceased to make themselves available or to communicate resulting in the problem noted below.

I called a meeting with Condo owners June 22, 2009 and hand delivered the meeting announcement to the residence of Bagdonas and Solana and all the condominium owners the preceding week. Neither Bagdonas nor Solano responded or attended the meeting. It was reported in the attached letter by the Schwartz Law Group, the attorney for the elected party to manage the association's business, that prompted me to call the meeting. It was reported in the attached letter from the Schwartz Group that the utility bills are not being paid and other obligations for the owners have gone unpaid. This firm represents the interests of Tristan's Construction, Inc., and Dr. Brent Sears, DMD. Mr. Tristan was voted a member of the board of directors for Venture Professional Center Condominium Association several months ago, yet has not been given access to the association's books and records.

We recently discovered Mr. Michael Bagdonas has disconnected his cellular telephone, and has not appeared at his office in approximately two (2) weeks. Additionally, the Association has failed to pay the landscaping company, resulting in their ceasing maintenance of the grounds, and Jacksonville Electric Authority is currently due eight hundred thirty nine dollars and fifty one cents (\$839.51), for water and electric service. Mr. Bagdonas has apparently disappeared without allowing my client access to the corporate books, records, and accounts, and therefore Mr. Tristan is unable to ensure payment for these necessities.

Be advised, Dr. Sears maintains a dental practice in the Venture Professional Center, and running water and electricity are crucial to ensure he is able to remain open. Additionally, this office requires electricity and water to remain open, as I will not subject my employees to working without access to an operating toilet, nor will I allow my clients to be subjected to the same conditions.

Should the New Structures, LLC fail to immediately remedy the instant situation, we will pursue all available remedies to protect our client's interest, including actions for injunctive relief, damages, and attorney's fees and costs. Be advised, should the electricity and/or water services be terminated for non-payment, such damages will rapidly accrue. As Mr. Bagdonas is your partner, his errors, omissions, and tortious conduct are the partnership's responsibility.

Mr. Tristan demands immediate access to the Association books, records, and accounts. Please advise as to your position on this matter within twenty four (24) hours.
