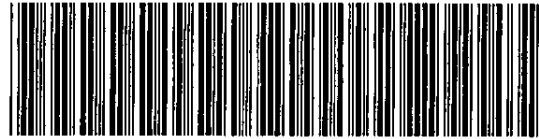

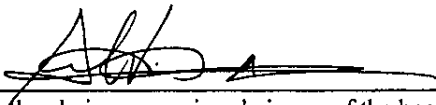

to
ARTICLES OF INCORPORATION FOR
Fiestas Patronales y Paradas de PR, Inc.**

ARTICLE I

The name of the corporation is Fiestas Patronales y Paradas de PR, Inc.

ARTICLE II

The address of the corporation's registered office is 1620 Spinning Wheel Dr, Lutz, FL, 33559

ARTICLE III

The period of its duration is perpetual unless dissolved according to state corporate statutes.

ARTICLE IV

The purposes for which the corporation is organized are:

To plan, promote, coordinate and execute, charitable programs/activities and cultural traditions. All purposes shall be exercised exclusively for charitable and educational purposes in such a manner that the corporation will qualify as an exempt organization under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue laws.

ARTICLE V

The Manner in which directors are elected or appointed is:

By the original board members.

ARTICLE VI

This Corporation is organized under a non-stock basis and the corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited in accordance with the organization's bylaws.

The bylaws of this corporation shall be adopted by the First Board of Directors, which bylaws may be altered, amended, modified or appealed in the manner set forth in the bylaws.

ARTICLE VIII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.
