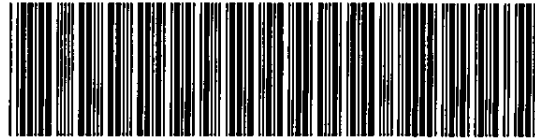

ARTICLE I NAME

The purpose for which the corporation is organized is:

THE PURPOSE FOR WHICH THIS CORPORATION HAS BEEN ORGANIZED IS:
